தமிழகத்தைச் சேர்ந்த சுதந்திர போராட்ட வீரான பூலித்தேவர் செப்டம்பர் 1ஆம் தேதி 1715 ஆம் ஆண்டு நெற்கட்டும்செவ்வல், திருநெல்வேலி மாவட்டத்தில் பிறந்தார்.

இந்திய விடுதலை வரலாற்றில் 'வெள்ளையனே வெளியேறு' என்று முதன்முறையாக 1755 ஆம் ஆண்டில் வீரமுழக்கமிட்டவர்.

இதனால் இந்தியாவின் முதல் விடுதலைப்போர் எனக் கருதப்படும் சிப்பாய் கலகத்திற்கும் (1857) முன்னோடியாகக் கருதப்படுகிறார்.

தமிழ்நாடு அரசு திருநெல்வேலி மாவட்டம் சிவகிரி வட்டம் பகுதியிலுள்ள நெற்கட்டும் செவ்வல் எனும் ஊரில் பூலித்தேவர் நினைவைப் போற்றும் வகையில் பூலித்தேவர் நினைவு மாளிகை திருமண மண்டபம் ஆகியவற்றை அமைத்துள்ளது.

Adopt Heritage 2.0 Programme

ASI (Archaeological Survey of India) to launch adopt Heritage 2.0 programme.

The Ministry of Culture said the ASI will launch this Programme that speaks to invite corporate stakeholders to enhance amenities at monuments by utilising their CSR funds.

The programme is a revamped version of the earliest scheme launched in 2017 and clearly defines the amenities sought for different monuments **as per Ancient Monuments and Archaeological sites and remains at (AMASR Act) 1958.**

CSR Funds - Corporate Social Responsibility (CSR) is the funding and grants process under which Non profit organization (NGO) can get financial and other support from the corporate sector.

The CSR provision governed by **the Companies act 2013**

According to the act corporate should **devote 2% of their average Net Earnings** over the previous 3 years.

- Philanthropic responsibility
- Financial responsibility

Invoice Incentives Scheme

It is announced by **the Ministry of Finance.**

Objective - To bring Behavioural change in the general public to ask for a bill as their right and entitlement.

Initially launched in the states of Assam, Gujarat, Haryana and Union Territory of Pudhucherry, Dadra & Nagar Haveli, Daman & Diu.

This Scheme will run for **a period of 12 months.**

Duplicate uploads and invoices with inactive or Fake GSTIN will be rejected by the system.

The Government has announced that it will given attractive reward of Rs.1 crore through this scheme.

Benefit of this scheme

- It will be available only to those traders who will upload GST.
- It motivate more people to take the GST bill.
- It will increase the income of the Government.

Mera Bill Mera Adhikaar
All you need to know

- 1** All invoices issued by GST-registered Suppliers of the States and UTs* to Consumers will be eligible for 'Mera Bill Mera Adhikaar' Scheme
- 2** The minimum purchase value for the invoice to be considered for lucky draw is ₹200
- 3** Individuals can upload a maximum of 25 invoices in a month
- 4** Monthly and Quarterly draw of lots will be held and winners will be eligible for Cash Rewards upto ₹ 1 crore

*Scheme is available from 2nd September, 2023 on pilot basis, in the *States of Assam, Gujarat and Haryana and UTs of Dadra & Nagar Haveli and Daman & Diu, and Puducherry*

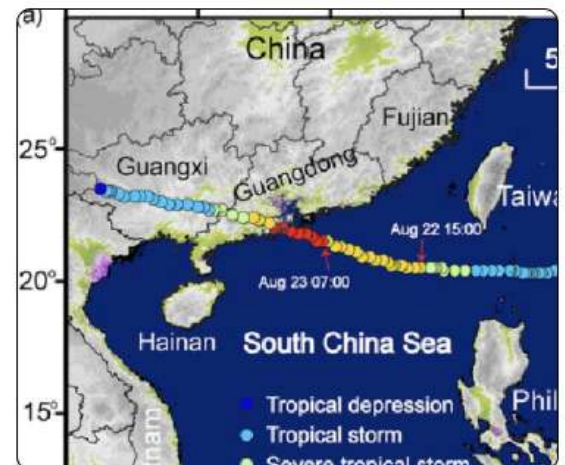
Super Typhoon Saola affects Southern China

It was strong tropical cyclones **affecting the Philippines, Taiwan and China.**

Typhoon is a natural disaster that refers to the formation of Tropical and Subtropical ocean cyclonic eddies in a wide range of activities with strong wind, Rainstrom, Storm tide and waves which may cause damage to humanlife and properties.

Causes of Typhoon

- Sufficiently warm sea surface temperatures .
- Atmospheric instability.
- High humidity in the lower to middle levels of the troposphere.
- Coriolis force to develop a low pressure center
- Pre-existing low level focus.
- Low vertical wind.



Different terminology used for weather phenomenon

- In the Caribbean Sea, the Gulf of Mexico, the North Atlantic Ocean and the eastern and central North Pacific Ocean - "**Hurricane**"
- In the western North Pacific - "**Typhoon**"
- In the Bay of Bengal and Arabian Sea - "**Cyclone**"
- In western South Pacific and southeast Indian Ocean - "**Severe tropical cyclone**"
- In the Southwest Indian Ocean - "**Tropical cyclone**"
